Action Taken Report on the basis of Feedback of various stakeholders.

1. As per the student feedback obtained, there is a sizable i.e. 32.7% of the students who were unsure about the contents and its completion. This aspect has been deliberated by the IQAC and it was decided to instruct the teachers to delineate the syllabus very minutely.
2. Students being the main stakeholders of any academic institution, his feedback is vital for stock taking of the delivery mechanism and for necessary course correction.
3. There is about 20% students who were critical of the evaluation process. This point was also discussed in the IQAC meetings with examination committee. It was decided to make the House Examination evaluation process more transparent and remedial. Since this is an affiliated institute of HPU and SPU, the external examination process is in the domain of the respective universities. Though the concerned of the students are raised by the college administration at the appropriate fora.
4. Though an overwhelming share of responses are in the good and very good category, the college will strive to improve further the very good by taking the following measures.
 - (a) New infrastructure is being added.
 - (b) More contemporary ICT facilities are being added.
 - (c) To give more accessibility to all the stakeholders the contact detail of the college administration and the faculty members are being made readily available at the official website.
5. Responses obtained from the alumni regarding association and network of old friends, college is calling the general house soon which was withheld for a long hiatus after the breakout of Corona pandemic. Also a Facebook page is to be created for a better connection among the alumni.
6. Regarding Canteen facilities it is pertinent to mention here that college canteen has been taken by the District Election Officer for storing the EVMs and a letter regarding its vacation has been sent. This college being a Government institution cannot disobey the orders of the Government.

7. Hostel facilities are in the process of upgradation and also a proposal to construct a new OBC hostel is in the pipeline. Also, we have also received extra funds for strengthening of Hostel infrastructure.
8. Industrial visits and placements are being strengthened and streamlined.
9. After the analysis of the Employers feedback more e-resources are being subscribed. For the augmentation of Lab infrastructure and ICT facilities, a new Science block at a cost of about 10 crores, a new B.Tech. block at a cost of about 4 Crores and a new MBA block at a cost of 3.2 Crores are nearing completion/ being constructed. Hopefully this will increase the employers' satisfaction to higher levels.

Though most of the feedback received from the parents is overwhelmingly encouraging, yet to most of the responses we have got shades of poor delivery. To us, it looks fallout of the two years of pandemic and non convening of the PTA meetings, to be updated about their concerns. Decreasing incidences of the pandemic and regular functioning of the college is likely to improve upon all the parameters.
